

PLAT CHANGES THAT COULD AFFECT YOUR HOME

Eagle Point Golf Community - Phase 16A

The Eagle Point Golf Community Homeowners Association Board of Directors has made many, many attempts over the past two years to bring The Holt Company to the negotiating table to discuss Phase 16 and its perceived negative impacts on homeowner value, traffic patterns through neighborhoods, and loss of green space, all with no positive response. Through a request for documentation to the City of Eagle Point about how Phase 16 was approved for construction, the Board discovered that the method of approval did not follow state and City law and public hearing requirements. That left the Board with only one choice - to bring a legal action against the City and Holt to force them to follow the proper regulations in approving the final plat for Phases 16 A and B.

Based upon our strong legal position going forward the Board continues to seek a resolution of all issues with Holt and the City that will benefit all homeowners in the community. The Board will update all homeowners as key decisions and agreements are made in this process.

• Community Wide Yard Sale

Because of the impacts of the Covid-19 Virus and directives formthe state to avoid events that drawlarge numbers of people, the annual Spring yard sale was cancelled. The board will monitor the progress of re-openings allowed , and will notify everyone about plans for a Fall yard sale in September.

- Landscape contractor: In the December 2019 Meeting the Board of Directors choose to stay with the previous landscaping company Bumgardner Landscaping
- HOA Branding: Over the next few months you will notice that the letterhead and envelopes
 have been changed from the CPM logos to the HOA logos in order to have consistency on
 the website, newsletter and all communications from the HOA. We have obtained nearly all
 the approvals for copywriting the name of the Homeowners Association and all the
 associated logos and names. Due to government office closings, it will be another 60 days
 before this process is completed at the state and federal levels. Once these tasks are
 completed no person or entity can use the EPGCHA name, symbols or logos without
 permission from the Board.

EPGCHA Yard Care Program

The Eagle Point Golf Community Yard Care Program (EPGCYP) is intended to streamline communication with homeowners, reduce violations and reduce the number of notice letters. The EPGCYP allows the Eagle Point Golf Community HOA (EPGCHA) to communicate directly with an approved landscape maintenance company to correct issues with landscaping that falls below the Community-wide Standard. For example, if a homeowner is away on vacation or extended holiday, and the sprinklers break and a lawn and other landscape begins to die, the pre-approved landscape maintenance company could quickly correct the problem. The landscape maintenance company will work with the homeowner to correct the issue or propose a plan to correct the issue with a timeline to complete. EPGCHA shall not ask the homeowner or landscape maintenance company to make any modifications or changes to existing landscape. This program will replace the existing violation process for EPGCYP program members. If the homeowner or landscape maintenance company is unwilling or unable to correct the issue EPGCHA will follow standard violation policy and procedures.

EPGCHA Yard Care Program Venders must be license and insured. All EPGCYP venders are required to keep the landscaping of your client's property up to the community-wide standard. EPGCHA validates each vender is license and insured and has agreed to keep the landscaping of client's property up to the community-wide standard and allowed EPGCHA to contact them for any maintenance that is needed to bring the property back to the community standard.

EAGCHA Yard Care Program Venders are independent contractors and employed by the home owners not EPGCHA.

If you are a landscape provider and would like to be part of this program and added to the approved list Please download the application found here and mail/e-mail or fax to CPM.

New Eagle Point Office Opening July 1, 2020:

Prior to COVID-19 social distancing your Board of Directors rented an office space at 177 Alta Vista Dr. Ste B for a local place where homeowners can go to discuss HOA business, with either CPM or a Board Member. It will also be used to hold Board Meetings and Modification Committee Meetings when COVID-19 regulations permit these types of activities again.

Your local HOA office will be opening up for businesses with required social distancing, sanitization, and health protections implemented on July 1, 2020.

The below guidelines outlined by the State of Oregon will be implemented in the local office:

- By appointment only, no walk-ins.
- All appointments (homeowner, board member, MC member, or vendor) would need to fill out a COVID-19 health Questionnaire and return it at least 2 hours prior to appointment time.
- Everyone would be required to wear a mask
- Everyone will need use hand sanitizer when entering the office and touching paperwork.
- After every appointment an office sanitation time period would be required before next appointment is permitted to enter the building.

These heath precautions are for your protection as well as the office staff. If you are not able to follow these guidelines, CPM is available by phone or email Monday – Friday 8:30am- 5:00pm.

CPM's Office hours are Tuesday, Wednesday, & Thursday 8:30 am – 5pm.

Landscaping Tips and Tricks from Bill at Bumgardners Landscape

Seasonal Blooms

Floral displays ring in the growing season with life and color. Annual flowers are a good landscape investment because they're versatile, colorful, quick to bloom and relatively inexpensive. These dependable single-season flowers hit the ground running and provide a spectacular show all season long. Annuals provide an entire spectrum of options in terms of size, color and growth patterns. Some flowers work well as edging plants. Others are best used in planters or window boxes. Most annuals can create dramatic displays when planted across large areas. Because annuals live only one season and have no permanent roots from which to grow the next year, they perpetuate their kind through heavy seed production. Biologically, seed and flower production go hand in hand. To produce lots of seeds, they must produce many flowers. If those flowers are cut before the seeds can form, the plant tries again and again in an effort to make up the loss. The more you cut an annual, the more it blooms, making annuals the gift that keeps on giving!

Some popular annuals that you may want to consider for your landscape include impatiens, zinnia, marigold, petunia, nasturtium, alyssum, aster, morning glory, portulaca, snapdragon and sweet pea. With the right planning, good soil, plenty of water and room to flourish, an annual flower display on your property will be a sight to behold.

Homeowners Meet and Greet:

Street Tree Information

Homeowners must submit a new Modification Request Form if they want to remove their existing pear tree and replant it. The only approved street tree replacement tree is the Chanticleer Pear tree. If the parking strip surface material is to change from material originally used, photos of the material type and color must be included in the new Modification Request.

All street pear trees that will be removed, must be replanted with the Chanticleer Pear tree. If your street tree pear tree is healthy it does not have to be replaced. As this is a newer resolution, please contact CPM for clarification or explanation. We are here to help.

While the MC suggests a 2.5" caliper tree trunk, the owner has discretion over the tree trunk size.
