Did You Know...Trash Can Do's & Don't

- Do place trash container(s) out the evening before trash collection day and make sure to bring the containers(s) in before the end of trash collection collection day.
- Don't store your trash containers where they are visible from the street.

Wood Privacy Fence Staining

As we head into dryer weather the time has come to stain your wood privacy fence. Section 3.3.3 of the Fence Resolution requires that wood privacy fences be stained on both sides with an HOA approved stain. If you have a new fence that has not been stained or an older fence that the stain is faded or showing water damage then those will need to be stained. The HOA will be monitoring this closely starting in April and notices will be sent out so please check your wood privacy fencing to see if it is in good condition.
