Are you aware that contractors are not permitted to work on Sundays or holidays in the community? This applies to landscape contractors as well and it's up to the individual homeowner to ensure their contractors are not working on these days.

#### 2024 Assessment Payment Reminders

- The EPGCHA assessments for 2024 have increased to \$95.00 per quarter.
